





2. DRAFT ARTICLES OF IMPEACHMENT

2. DRAFT ARTICLES OF INTEACTIVIENT Once the inquiry is complete, the Judiciary Committee will decide if there is enough evidence to convict the President and draft article of Impeachment. Article 2 of the Constitution indicates that is to be removed from office for treason, bribery, or other high crimes and misdemeanors.

A person who exposes any kind of information or activity that is deemed illegal, unethical or not correct within an organization that is either private or public. The 1989 Whistle Blower Protection Act was enacted to protect federal employees who disclosed government illegality, waste and corruption from adverse consequences. This act provides protection to whistle blowers who may receive demotions, pay outs or a replacement employee.
